UIAA CONDITIONS FOR INTERNATIONAL ICE CLIMBING COMPETITION LICENSES

OBLIGATIONS OF TEAM OFFICIALS

By applying for an International Team Officials License the holder acknowledges and accepts the rules and anti-doping policy and procedure of the UIAA World Ice Climbing Board and commits him or herself to act according to these rules and procedures.

1. In connection with anti-doping procedures the team official:

- Recognise that, as an Athlete Support Personnel, I am subject to the jurisdiction of UIAA for the purposes of anti-doping.

- Expressly consents to submit to all methods of testing (blood, urine, gases, etc.) and any medical, clinical, or biological testing conducted either out of competition or at a competition by the Member Association, the UIAA Ice Climbing Commission, the World Anti-Doping Agency (WADA) and/or their appointed testing authority for the purpose of revealing if a prohibited substance is present in his or her body or to reveal the possible use of prohibited substances or methods;

- Expressly acknowledges the right of WADA to perform out-of-competition tests for the UIAA.

- For the purpose of out-of-competition testing undertakes to inform his or her Member Association in advance of the places he or she intends to train;

- Expressly acknowledges the right of the UIAA to join as a party to any disciplinary proceedings or arbitration in connection with alleged doping offences.

2. Team Officials applying for an International Team Official License also acknowledge and accept that:

- In UIAA Ice Climbing Competitions they understand and abide by the regulations and rules of the sport and observe the principles of good sportsmanship - accepts to have read, understood and abide by the UIAA Code of Conduct;

- Accept, subject to the official appeal procedure, the decisions of the official judges without question or protestation and exercise self-restraint at all times;

- Treat other competitors, officials and others involved in the practice of the sport with full and due respect at all times, both during and outside a competition.

- Safety is a primary concern at Ice Climbing Competitions nonetheless a certain risk of personal injury or death remains;

- Accept the risks of participation and are responsible for their own actions which should take into account relevant circumstances such as changing weather and snow/ ice conditions.

OBLIGATIONS OF UIAA MEMBER ASSOCIATIONS

A Member Association whose Team Officials apply for an International License must:

- Ensure Team Officials are aware of, understand and accept their obligations and the risks and responsibilities of being part in ice climbing competitions;

- Maintain an up-to-date list of contact details and addresses of holders of International Team Official Licenses;

- Immediately inform the UIAA of any positive result of a doping test and commence a disciplinary proceeding against any Team Official who has been involved in a positive test for doping and to inform UIAA about such proceedings;

- Ensure all its applicants for International Team Officials Licenses have liability and accident insurance covering ice climbing competitions and are medically fit to be involved.

NOTES ON UIAA INTERNATIONAL ICE CLIMBING COMPETITION LICENSE

1. Objective

To allow Team Officials to participate in official international events.

2. Obtaining the license

This form must duly be completed and signed by the team Official and the UIAA Member Association. Once the UIAA Office receives written approval of the Team Official as well as the payment (or agreement to pay the invoice at the end of the season), the UIAA Office announces online the status "approved".

3. Format of the international license

The international license is this document duly signed and received by the UIAA Office in Bern. The Team Official will then have his/her name on a list made public for every competition organizer to have immediate access to. Validity of each license expires at the end of the respective calendar year.

4. Price

The international license is sold by the UIAA to the Member Association and then to the team official. The price of the UIAA International Ice Climbing Team Official License for the **2026** season is **EUR 50**. Payments can be made prior to the season, the federation can request an invoice at the end of the season, or the Team Official will be asked to pay the license fee by credit or debit card, upon sign-in at their first event of the season.

5. Application

All Team Officials (including youth categories events) attending International UIAA Ice Climbing Competitions are requested to be in possession of an International License issued by the UIAA.

6. Authority

An International License is compulsory for all official events. Those Team Officials for whom their belonging Federations have not applied or approved for an International License, will NOT be allowed to be involved in UIAA approved events.

7. Data Protection

The UIAA World Ice Climbing Board will only use the data from International License for the purpose of anti-doping procedures, events organization and transmitting information on Ice climbing.
